## FEC RELEASES INDEX OF 1977-78 INDEPENDENT EXPENDITURES

WASHINGTON - NOVEMBER 3, 1978 - The Federal Election Commission today released a report on independent expenditures made on behalf of U.S. House and Senate candidates during the 1978 Congressional election cycle.

The Index of Independent Expenditures lists 18 Senate and 51 House candidates for or against whom independent expenditures have been made. Based upon reports filed as of October 10, 1978, the total amount of money spent independently to influence federal elections currently is \$104,901.

An independent expenditure is an expenditure made by a person or group of persons "for a communication expressly advocating the election or defeat of a clearly identified candidate." The expenditure must be made without any consultation or coordination with the candidate or his/her campaign committee(s) or staff.

Independent expenditures are reported at the end of the reporting period in which they are made; with the exception of those made less than 15 days, but more than 24 hours prior to an election, in which case, they are reportable within 24 hours.
